NOTIFICATION

In continuation of this department notification number of even number dated 24.12.2005, the Government has further decided as under:-

i.) The instructions referred to above, will be applicable for all purposes including transfer cases.

ii.) The medical certificates of private practitioner will not be entertained/accepted except those Private practitioners who have been appointed by the Govt. as AMIAs and they are authorized to issue medical certificate for less than seven days only. For more than seven days the patient shall be referred to the specialists of Govt. Hospitals/recognized hospitals.

ii.) Medical Officer/Causality Medical Officer posted in IGMC DR.RPGMC, Tanda HP Govt. Dental College, Shimla as well as Registrars possessing MBBS qualification are authorized to issue the Medical certificate for less than 7 days only and thereafter patient shall be referred to the consultants by them.

iii.) The Registrars of IGMC, Shimla Dr.RPGMC, Tanda HP Govt. Dental College, Shimla are also authorized to issue medical certificates only upto 7 days in case they are possessing P.G. qualification. Thereafter the patient will be referred to the consultants faculty i.e. Asstt. Prof., Associate Prof. Professors by them. The Junior residents i.e. P.G. students of above referred colleges are not be allowed to issue the Medical certificates.

NOTIFICATION

It has been observed that Medical Officers posted to PHC's/CHC's and other Government Hospitals, are advising rest to the Government employees for long periods without any justification which is not in the public interest. Moreover, this trend is specially seen when the concerned employee is under transfer to Tribal Area or to a place not of his/her choice. In order to check this tendency, it has been decided by the Government that medical officers will be entitled to advise rest for not more than 7 days at a stretch. In case more than 7 days rest is required by the concerned employee in the opinion of the Medical Officer he will refer such cases to the nearest Govt. Health Centre which has the specialists for a thorough check up so that this practice could be overcome to avoid leave on medical grounds frequently.

The above instructions will also be applicable to the Ayurvedic Medical Officers of the Ayurvedic Department. In view of this, all Medical Officers posted in PHC's/CHC's and other Government Hospitals including Ayurvedic Medical Officers of Ayurvedic Department are directed to adhere to the above instructions in letter and spirit. Violation of these instructions as issued by the Government invite disciplinary action against the doctor concerned.
