The Government of Himachal Pradesh had created a separate Directorate of Health Safety & Regulation vide Notification No. Health-A-B(12)1/2002 dated 1<sup>st</sup> June, 2009 for the effective implementation and monitoring of various Acts applicable to health sector in the State of Himachal Pradesh. The Directorate is being headed by the independent IAS/ HAS officer and reporting directly to the Government of Himachal Pradesh. At present this Directorate is looking after the implementation and regulation of various Acts/Rules/Schemes in the State of Himachal Pradesh:
