लोग भी इनके झांसे में फंस रहे हैं व अपने खून पसीने की कमाई बर्बाद कर रहे हैं। शुक्रवार को जब इसकी भनक प्रशासन को लगी तो तुरंत पुलिस को आदेश कर इन झोला छाप डाक्टरों को शहर से खदेड गया। एस.डी.एम. रोहड् बाबू राम शर्मा ने बताया कि लोग इस तरह वे किसी भी डाक्टर व वैद्य के चक्कर में न फंसे, क्योंकि बिना डिग्री के यह झोला छाप की दवाई से उल्टा असर भी पड सकता है। इसलिए इनके चंग्ल में न फंसें। उन्होंने कहा कि यदि शहर या गांव करने में भी इस तरह से कोई बाहरी बैठा है, हो इसकी सूचना प्रशासन को दे।

It has been noticed that there are many fake private medical practitioners/Bengoli Doctors/Jholachap Doctors in the State. They are selling alloapathic drugs to the patients and are health quackery, especially in rural areas without any registration and thereby endangering the Health & Safety of the general public at large.

The Hon'ble Health and Family Welfare & Ayurveda Minister to Government of Himachal Pradesh, Dr. Rajiv Sehjal has expressed serious concern about this and has desired that such fake and illegal medical practitioners should be identified and strict action be taken against them.

1. The Clinical Establishment (Registration and Regulation) Act, 2010 (hereinafter referred to as "Act") has been enacted to provide for registration & regulation of Clinical Establishment in the country with a view to prescribe the minimum standards of facilities and services provided by them.

Section 11 of Act mandates the registration of Clinical Establishment in accordance with the provisions of the Act.

Section 40 provides for imposition of fine upon persons contravening any provisions of the Act which may extend to Ten Thousand Rupees for the first offence and for any second offence with fine which may extend to Fifteen Thousand Rupees and for any subsequent offence with fine which may extend to Five Lakh Rupees.

Section 41 provides for monetary penalty for non registration up to Fifty Thousand Rupees on first contravention, for second contravention with a monetary penalty which may extend to Two Lakh Rupees and for any subsequent contravention with a monetary penalty which may extend to Five Lakh Rupees.

As per Section 41(2) whoever knowingly serves in non-registered Clinical Establishment under this Act, shall be liable to monetary penalty which may extend to Twenty Five Thousand Rupees.



As per Section 42 of the Act provides for imposition of monetary penalty which may extend to Five Lakh Rupees for disobedience of direction, obstruction and refusal of information.

As per Section 43 provides for imposition of fine which may extend to Ten Thousand Rupees for minor deficiencies.

Under all these Sections as quoted above, the power to impose fine has been vested on the District Registering Authority (Clinical Establishment Act.) -cum Chief Medical Officer of the respective District and necessary proceedings in that regard have to be initiated by the concerned office

1. As per Section 27 (b) (ii) of the Drugs and Cosmetic Act, if any unauthorized person (as per section 18 C) is found Selling or Distributing Allopathic medicines there is provision of imprisonment for a period of three to five years with fine not less than one lac rupees or three times the value of drugs confiscated, whichever is more. In such cases, the power to launch prosecutions is vested with respective drug inspectors.

You all are therefore, requested to identify the fake/ illegal medical practitioners/Jholachap Doctors/Bengali Doctors within your jurisdiction involving local Drugs Inspector, all other staff in the field and take action in the light of the provisions mentioned herein above under the Clinical Establishment (Registration and Regulation) Act, 2010 AND/OR The Drugs and Cosmetic Act 1940.

The action taken in this regard shall also be shared with this office as well The Director Health Safety & Regulations, on quarterly basis. It has also been decided that this item shall form part of the bimonthly review meetings of CMOs.
