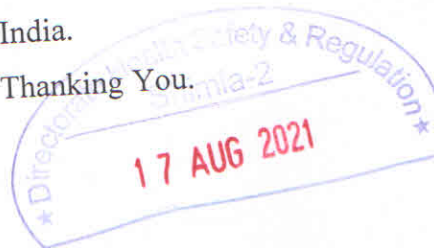

Sir/Madam,

As you may be aware, that Section 19 of the Clinical Establishments (Registration and Regulation) Act, 2010 (the Act) provides for issuance of duplicate certificate of registration for clinical establishments. The same is reproduced as under:

"19. Duplicate certificate.—In case the certificate is lost, destroyed, mutilated or damaged, the authority shall issue a duplicate certificate on the request of the clinical establishment and on the payment of such fees as may be prescribed."

2. It is to inform that now the process of registration of clinical establishments, including filling up application form, approval/rejection of registration by the registering authority, and generation of registration certificate is fully functional in the online mode through the web portal "www.clinicalestablishments.gov.in". The certificate for registration is issued in pdf format through email to the user/applicant/clinical establishments and can also be accessed online by logging in by the user/applicant/clinical establishment by following the process as mentioned under:

- (i) Go to the Portal www.clinicalestablishments.gov.in
- (ii) Click the registration button on the Home page
- (iii) Using your Login Credentials, log on to your Dashboard.
- (iv) Download Certificate (from the pdf link given in Action Column)

3. In view of the above, there is no requirement of applying for or payment of any fee etc. on account of it for issuance of duplicate certificate as provided under Section 19 of the Act. Hence the aforesaid compliance of the need for applying

for duplicate certificate, etc., has been done away with by making the process of registration online.

4. You are requested to disseminate this information among the Clinical Establishments & hospitals in your respective State/UT, so that they are able to act accordingly, as it potentially reduces compliance burden. It is further requested that this information may also be uploaded on your Ministry's website.
