1. Licensing Authority for grant, retention and renewal of various licenses for manufacturing of drugs, cosmetics and medical devices as well as testing labs, Blood Banks for the State of Himachal Pradesh and approval of RMI under NDPS Act etc.
2. Change of constitution of firms and addition/ deletion of facilities.
3. Form 29 for specialized products and products under CLAA (Central License Approving Authority).
4. Grant of additional products in specialized categories and Kokate committee products etc. and NOC products.
5. Suspension and cancellation of licenses.
6. Other works covered under the provisions of Drugs & Cosmetics Act, 1940 and rules made thereunder.
