Notification

In pursuance to the letter No.PER(AP)C-B(2)-2/2015 dated 2nd December, 2023 issued by the Department of Personnel and on the recommendations of the Screening Committee, the Governor, Himachal Pradesh is pleased to order regularization of services of the following contractual Drug Inspectors, on completion of two years service, in the Department of Health Safety and Regulations, in the Pay Scale as per Rule 3(j) of HPCS (Revised Pay) Rules, 2022 in Cell-1 of Level-12 of the Pay Matrix (i.e. Rs.43,000-1,36,000), on regular basis, with immediate effect:-

The terms and conditions of regularization are as under :-

- (i) That on regularization, the officers shall be appointed on the minimum of the time scale and fixation of pay will be done under the provisions of rules and orders/instructions in force issued from time to time.
- (ii) The officers will be on probation for a period of two years from the date of joining the post. The period of probation is liable to be extended at the discretion of the Appointing Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority, will render them liable to be discharged from service.
- (iii) The officers shall have to pass the prescribed departmental examination within the probationary period, failing which they shall not be eligible for:-
 - (a) The grant of higher pay scale etc.
 - (b) Confirmation to the service; and
 - (c) Promotion to the next higher post.



- (iv) The appointment may be terminated at any time by one month's notice given by either side viz. the appointee or the appointing authority. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period by making payment of a sum equivalent to the pay and allowances for the period of notice or the un-expired period thereof.
- (v) The officer will be liable to serve anywhere in the State of Himachal Pradesh.
- (vi) The regularization shall be subject to the verification of character and antecedents, as provided in the H.P. Financial Rules.
- (vii) The regularization of the officers shall be subject to the production of Medical Certificate of fitness from the Chief Medical Officer.
- (viii) The Officers will be required to take an oath of allegiance/faithfulness to the Constitution of India (or make the solemn affirmation to that effect) in the prescribed form.
- (ix) A declaration to the effect that the appointee had not/shall not have more than one living spouse/shall not marry a person who has living spouse.
- (x) Other conditions of service will be governed by the relevant rules and orders issued by the State Government from time to time.
- (xi) The officers are required to produce all original certificates in support of their academic/technical qualification, age and reserved class against which they were appointed as such.
- (xii) If any declaration given or information furnished by the Officers is proved to be false or if found to have wilfully suppressed any material/information, will be liable for removal from service and such other action as may be deemed necessary.

The above officers are directed to join their duties at their respective places of posting within 7 days and submit their joining reports to this Department through proper channel.
