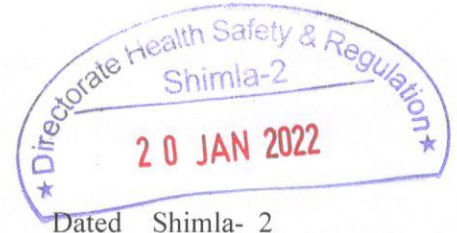

OFFICE ORDER

The terms and conditions of regularisation are as under :-

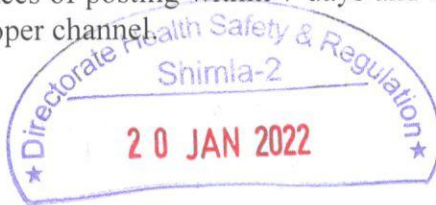
Terms and Conditions:-

- (1) That on Regularisation, the officers shall be appointed on the minimum of the pay scale i.e. Rs. 5910-20200 + 3000 and they will be entitled to get the revised pay scale of Rs. 10300-34800 + 4200 after completion of 2 years of regular service.
- (2) These Food Safety officers will be entitled to draw dearness and other allowances at the rate admissible and subject to the conditions laid down in the rules and orders/instructions in force issued by the State Government from time to time.
- (3) The Regularisation shall carry with it the liability to serve in any part of Himachal Pradesh.
- (4) The Regularisation will be on probation for a period of 2 years and during the period of probation his/her service can be terminated at any time by giving one month's notice or pay in lieu thereof by the appointing authority without assigning any reason.
- (5) The regularisation is subject to the Character and antecedents of the candidates being found satisfactory on verification.

- (6) The regularisation will be further subject to the condition of following certificate/declarations:-
- (i) Certificate of Medical fitness issued by the Medical Board.
 - (ii) A declaration to the effect that the appointee had not/shall not have more than one living spouse shall not marry a person who has living spouse.
 - (iii) Taking to an oath of allegiance/faithfulness to the constitution of India or making a solemn affirmation.
- (7) The Officers are required to produce all original certificates in support of their academic/technical qualification, age and reserved class against which they appointed as such.
- (8) The regularisation of the aforesaid Food Safety Officer is subject to the outcome of LPA No. 64/2020 titled as Sudha Batta Vs H.P. Staff Selection Commission & others & LPA No.65/2020 titled as Kamal Kumar Bhardwaj Vs H.P. Staff Selection Commission & others.

If any declaration given or information furnished by the officers is proved to be false or if found to have wilfully suppressed any material information, will be liable for removal from service and such other action as may be deemed necessary.

The above officers are directed to join their duties at their respective places of posting within 7 days and submit their joining reports to this Directorate through proper channel.
