**OFFICE ORDER**

On the recommendations of the Secretary, Himachal Pradesh Staff Selection Commission, Hamirpur conveyed vide letter No. HP-SSC-C-(2)14/2019-737(R-11)-617 dated 05/02/2020, the following candidates are hereby appointed as Senior Scientist on consolidated amount of Rs. 14100/- (i.e. Rs. 10300+3800 Grade Pay) + 125% of grade pay per month purely on contract basis. The said appointment is further subject to acceptance of terms and conditions of the appointment:-

**Terms and Conditions**

- (1) Since the appointment is being given purely on contract basis, the appointee will have to execute a bond on the judicial paper with the Director Health Safety & Regulation Himachal Pradesh, in case the terms and conditions of the appointment are acceptable to him. The joining report will be acceptable only after the execution of the requisite bond as per **Annexure – A**.
- (2) The educational and professional qualification possessed by the candidate will be the same as prescribed in Recruitment & Promotion Rules framed by the Government for the post of Senior Scientist. The Director Health Safety and Regulation Himachal Pradesh will ensure that educational and professional qualification possessed by the candidate is from a recognised university and in case of non fulfilment of requisite qualification, the matter will be brought to the notice of undersigned where upon the services shall be terminated without assigning any further reasons. The relevant documents of Senior Scientist being appointed under reserve category may also be verified and if the verification reveals that the claim belonging to reserve category, as the case may be is false, similar procedure shall be followed as in case general category candidate.
- (3) The candidate (s) are required to submit attested copies of relevant Certificates of Educational qualification from any recognised board/university/ including certificate with proof of age at the time of joining in the Directorate of Health Safety and Regulation Himachal Pradesh. All necessary verification to this effect is to be made by the Director, Health Safety and Regulation Himachal Pradesh at the time his joining.

- (4) The appointee is liable to serve in any part of the State, as per the administrative requirements of the department and shall have to serve at least one term in the tribal / difficult areas. If posted in non tribal / non difficult area he shall be posted at any time in tribal / difficult areas as per the administrative requirements of the department.
- (5) The contractual appointee will be paid fixed contractual amount Rs. 14100/- (i.e. Rs. 10300+3800 GP) + 125% of grade pay per month. The contract appointee will be entitled for annual increase in contractual amount @ 3% of the minimum of pay band plus grade pay. The said annual increase in contractual emoluments for the subsequent year will be allowed if contract is extended beyond one year. Apart from this the contractual appointee will be entitled for enhancement if any, is given by the Government from time to time.
- (6) The contract will be renewed on year to year basis by the Director, Health Safety and Regulation Himachal Pradesh, subject to good performance and good conduct.
- (7) The services of the contract appointee will be purely on temporarily basis. The said appointment is liable to be terminated in case the performance/conduct is not found satisfactory.
- (8) The contractual Senior Scientist will be entitled for one day casual leave after putting of one month service. 10 days medical leave and 5 days special leave are also admissible and can be accumulated upto one calendar year. He will not be entitled for medical reimbursement and LTC etc. Only maternity leave will be admissible in terms of Maternity Benefit Act, 1961, to the female appointee.
- (9) Unauthorized absence from duty without approval of the Controlling officer/ competent authority shall automatically lead to the termination of the contract. A contractual Senior Scientist will not be entitled for contractual amount for the period of absence from duty.
- (10) The transfer of Senior Scientist appointed on contract basis will not be permitted from one place to another in any case. An officer appointed on contract basis who has completed 3 years tenure at one place of posting will be eligible for transfer on need basis wherever required on administrative grounds, except as stated in terms and conditions number - 4.
- (11) The selected candidate will have to submit a certificate of his fitness from an authorized Government Medical Attendant. In case of women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The Women candidate will be re-examined for fitness by an authorized Medical Officer/ Practitioner before she is allowed to join duty.
- (12) The contract appointee will be entitled to TA/DA if required, to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart at the minimum of pay band + grade pay.
- (13) The provisions of service rules like Fundamental Rules, Supplementary Rules, GPF Rules and Pension Rules etc. as applicable in case of regular employees will not be applicable to the contract appointees.

- (14) The appointment to the service shall be subject to order regarding reservation in the service for scheduled caste /scheduled tribes /other backward classes /other categories of the persons issued by Government of Himachal Pradesh from time to time.
- (15) The candidate have to give a declaration to the effect that he has only one living spouse, if married.
- (16) The candidate has to take an oath of allegiance/faithfulness to the Constitution of India or making solemn affirmation.
- (17) The appointee (s) should be a Bonafide resident of Himachal Pradesh.

If these specific as well as usual terms and conditions are acceptable to the candidate(s), he/she will report to the Director Health Safety and Regulation Himachal Pradesh within 15 days for further directions. The documents as required will be produced in terms of this order and will also execute requisite bond of contract, failing which the offer of the appointment shall automatically stand cancelled and the candidate will have no right to claim it.
